- one-year complimentary membership to the state chapter (\$20.00 value)
- a letter of recognition for the recipient's professional portfolio and for his/her employer
- the Arizona Radiology Nurse of the Year Award Certificate
- recognition for the accomplishments posted on the chapter's website with a picture of the Radiology Nurse of the Year

AZ Radiology Nurse of the Year Award Criteria:

- Must be a currently licensed registered nurse working in a radiology setting
- May be nominated by anyone
- Current Board of Directors are not eligible to be nominated
- Adherence to standards of practice appropriate to radiology nursing
- Evidence of ongoing education relevant to radiology nursing
- Advocates for quality patient care
- Demonstrates leadership and is a role model for excellence in radiology nursing
